Official Rules and info:

1. **Entry forms:** Entry forms must be submitted no later than Friday, November 14, 2008. Please return entry forms to Joy Coomer, 365 James Elledge Rd, Honea Path, 29654 .
2. Entry is free.
3. **Prizes:** Prizes will be given out based on the number and type of entries.
4. **Lights:** This is a night parade. Every effort is made to light the parade route, however, it is strongly suggested that each entry be lighted in some way. It makes for a dazzling display for the audience.
5. **Inclement weather:** In the event of inclement weather, the parade will be held December 6, at 10:00 AM.
6. **Official line up:** The official line up area will be the parking lot of Hickory Tavern School. Please have your entry number posted in your windshield as this is the only way you will be allowed to enter the parade line up area. Find your corresponding entry number on the ground. Each vehicle that is part of the parade must have the same number displayed in it's windshield.
7. **Children:** Groups involving children must be accompanied by adults at a ratio of 1:10 Preferably 1:8
8. **Drivers:** All drivers and automobile operators must have a valid driver's license.
9. **Throw outs:** It is strongly encouraged that each entry have candy, etc. to throw to the crowd
